## About Us

The Tulalip Tribes is a federally recognized Indian tribe located on the Tulalip Reservation in the mid-Puget Sound area bordered on the east by Interstate 5 and the city of Marysville, Washington; on the south by the Snohomish River; on the north by the Fire Trail Road (140th St.); and on the west by the waters of Puget Sound. The Tulalip Reservation exterior boundaries

enclose a land-base of 22,000 acres, more than 50 percent of which is in federal trust status. The Reservation is rich with natural resources: marine waters, tidelands, fresh water creeks and lakes, wetlands, forests and developable land. The Tulalip Reservation was reserved for the use and benefit of Indian tribes and bands signatory to the





Treaty of Point Elliott of January 22, 1855. Its boundaries were established by the 1855 Treaty and by Executive Order of President Ulysses S. Grant dated December 23, 1873. It was created to provide a permanent home for the Snohomish, Snoqualmie, Skagit, Suiattle, Samish and Stillaguamish Tribes and allied bands living in the region.

## Introduction

The Tulalip Tribes Services Directory aims to provide information on our departments' programs and services, and eligibility requirements. The tribe provides many services to its members including early learning/Montessori, higher education assistance, health and dental clinics, a pharmacy, youth activities, a state-licensed chemical dependency recovery program, mental health, senior retirement home, and cultural activities. Contact information is included for each department if you have additional questions beyond what is listed.

92% of our government services, tribal member entitlements, family and senior housing, education, health and dental services, law enforcement, fire protection, infrastructure improvements, and economic growth are funded from within.

**VISION:** Tribal members who are home bound are safe, supported, cared for, and valued.

**MISSION:** Provide caregiving to homebound clients that supports in-home care and assists families.

**VALUES:** We respect the community of our elders past and present, and pay attention to their good words. We uphold and follow the teachings that come from our ancestors. It is valued work to uphold and serve our people. We work hard and always try to do our best. We show respect to every individual. We strengthen our people so that they may walk a good walk.

### **SERVICES PROVIDED:**

- We assist with completing application for services. All applicants are required to apply for State services. Approved State hours may be different from what the Tulalip program approves. Assist with State assessment, based on client needs. Act as a liaison between client and caregiving agency
- We are a resource and support for the person receiving caregiving hours and their family
- Distribute medical supplies (Depends®, drink supplements, bed pads, etc.) to elders and people eligible for the caregiver program

**MISSION:** Provides culturally based programs to nurture our children, families and community members by honoring our cultural teachings and values, for the wellbeing and preservation of future generations.

**Accepts referrals from:** All court systems, Department of Corrections, schools, Charles Denny Youth, employers, CPS, *bədaʔchəlh*, state licensed mental health agencies, self.

## Child Support

**MISSION:** To ensure every child's right for support financially, medically, emotionally and culturally from both parents, through collaboration with all agencies and departments. Endeavor to improve the standard of living for all children, arriving at a time when each and every person will become most capable.

### SERVICES PROVIDED:

- Promote accountability for financial, medical access through enforcement of child support for the children
- Ensure the non-custodial parent is satisfying the financial responsibility set by a court to provide the needs of the children
- Maintain relationships with agencies or departments to enforce or set child support orders
- Partnering with TANF has omitted any chance of tribal TANF overpayment due to child support

**ELIGIBILITY REQUIREMENTS:** We service everyone—tribal and non-tribal members.

adopted child placed within a family unit in which any member is an eligible AI/AN. (Please provide legal document or written letter from eligible AI/AN.)

**FUNDING AGENCY:** Grants and tribal hard dollars.

## Children's Advocacy Center (CAC)

**MISSION:** To provide education, advocacy, and a multi-disciplinary response to decrease re-traumatization of children who are victims of crime.

Our Children's Advocacy Center is accredited by the National Children's Alliance. Currently there are only four tribes in the United States that hold this accreditation. Tulalip is the only tribe in Washington State that has an accredited Children's Advocacy Center.

### SERVICES PROVIDED:

- Specialized child forensic interviews in a child and family-friendly setting
- Specialized trauma therapy for child victims and their families
- Education on prevention of and responses to child sexual abuse
- Education on identifying child abuse in all its forms, and how to respond
- Ongoing consultation with medical professionals, educators, social workers on child abuse issues

**ELIGIBILITY REQUIREMENTS:** Any child who has been a victim of crime can use our services. The parent or guardian can call the child advocacy center and ask to talk with the manager, or the child advocate to see which services would best fit the child's situation.

## Code Enforcement

**MISSION:** Enforce provision of the code to:

- Commit to conduct prompt, thorough and effective investigation and assistance;
- Aim to help improve the environment and protect the land for future generations;
- Create better understanding about Tribal Reservation resources in the Tulalip community;
- Provide the community with excellent service

**SERVICES PROVIDED:** The purpose of the Tulalip Tribes Code Enforcement is to provide guidelines for:

- The prioritization of code enforcement cases;
- Investigation of code violations;
- Enforcement of Tribal codes through voluntary compliance first prosecution of code violators who do not comply;
- Recovery of the Tulalip Tribes investigation and enforcement cost

**ELIGIBILITY REQUIREMENTS:** We service anyone who does not comply with Tribal codes, tribal and non-Tribal reservation residents.

## Crisis Response

**MISSION:** To support the community when in crisis, or questioning if there is a crisis.

**SERVICES PROVIDED:** Critical mental wellness situations (suicidality, uncontrolled anxiety, debilitating depression, etc.). Critical substance recovery needs where the CRT are able to connect services during that golden moment of clarity and desire for treatment.

- Provide knowledge of a Tribe's culture and how to provide culturally relevant care for people in crisis
- Provide a quicker response time for time-sensitive and life-saving care. This means people receive the care and services they need much faster than calling in someone unfamiliar with an individual or community
- Understand the complexities and challenges of Native peoples and how to navigate the Tribal health care system and available county and state resources

### **Examples of when to call the Mobile Rapid Response Crisis Team (MRRCT):**

- Suicidal thoughts: with or without weapons AND with or without a plan
- Homicidal thoughts: with or without weapons AND with or without a plan
- Active psychosis (organic and/or substance induced): panic attacks, manic behavior
- Assistance with voluntary in-patient psychiatric hospitalization
- Mental health measures (i.e., PHQ-9, BDI): score is moderate to severe and clinically presenting distress

#### **In-Person Hours:**

Monday – Friday, 8:00 AM – 4:30 PM

#### **After-Hours Support:**

*Available by phone and text*

- Schools: when police or MRRCT are called for disruptive behaviors; MRRCT can respond since this is considered behavioral health
- Older Adults: dementia, wandering, elopemental disoriented, or displaying other dementia-like symptoms
- Frequent callers: identified Tribal members whose frequent 911 calls are suspected to be related to behavioral health issues (both mental health and/or substance abuse)
- Death: when requested by family, MRRCT may be available for individuals/-family members/friends to offer support
- Suspicious calls: when requested by TPD, MRRCT can gather information and calm individuals in distress while the police search for suspicious activity
- Car accidents: when requested by TPD, MRRCT may be able to assist with deescalating frantic parties while police do their work

- Substance abuse: detox and referrals coordinate with Substance Use Disorder (SUD) department 24/7 425-754-2535

This commitment recognizes the importance of minimizing trauma for victims and their families, holding offenders fully responsible for their conduct, and providing appropriate intervention and prevention services to elders/vulnerable adults. The case manager is available at the Senior Center to assist with elder/vulnerable adult exploitation, abuse, and neglect.

**SERVICES PROVIDED:** We assist with applications for benefits, safety plans, and help find resources available within Tulalip and outside Tulalip. Assist clients finding appropriate housing. Act as liaison with protective payee, departments within the Tulalip Tribes and Washington State agencies. Assist clients with creating budgets. Perform investigations of allegations of abuse, neglect and exploitation. Act as guardian for several Tulalip tribal members which includes assuring social, medical and cultural needs are being met. Assist families with adult guardianship.

## Enrollment

**MISSION:** To protect the records of tribal membership. To assist our tribal community with trust, integrity, accuracy and confidentiality. To complete each members file to ensure the enrollment of future generations.

### SERVICES PROVIDED:

- Enroll members into the Tulalip Tribes of Washington
  - **Tribal ID Card:** one free in calendar year and \$5 otherwise. Cards are encoded with your tribal ID and gas card number. Once you get a new ID the old card will be void, be sure to use your most current ID to receive the gas discount. Tribal ID cards are available Monday–Friday, 8:00 AM–4:30 PM (closed for lunch from 12:00 PM–1:00 PM, unless scheduled)
  - **Tribal Spouse ID Card:** \$40 first one, \$20 renewal, only done on Thursdays. Cards allow you to get tax exempt on reservation, get a free YMCA membership, free use of the tribal dump and verification of being a spouse for Employment. Tribal member and spouse must be present each time a card is received. Cards are valid for one year
  - **Minor Trust Distributions (subdivision with the Enrollment Department):** Minor trust distribution age 18 with high school diploma or GED, age 22 without. Divided into four distributions
    - In person and Zoom option for minor trust financial class
    - Meeting with a financial advisor prior to 3rd distribution
- Early release for certain circumstances with proper documentation. This has to be reviewed by the Minor Trust Committee and approved
- **Family Tree:** Members can request in writing for an ancestry, decacyency or kinship report
- Provide supporting documents to members
- Manage the mail-out list
- Assist with per capita payments

**What information is provided over the phone regarding enrollment?** If we can verify who you are we give your enrollment number.

## **Enrollment** (continued)

**How often do you meet to enroll new tribal citizens?** The enrollment committee meets twice a month. If an application is approved, we recommend it to the Board of Directors for enrollment.

**How do I change my address for per capita, enrollment and mailings/syəcəb?** Requests must be made in writing, either by letter, fax, or email—if by email we need last address on file, date of birth, tribal enrollment number and last 4 digits of Social Security Number to verify identity. If we do have a questionable email, we don't change address until we get complete verification.

**ELIGIBILITY REQUIREMENTS:** To be enrolled at least one of your parents must be an enrolled Tulalip tribal member. The enrolled parent must also prove residence on the Tulalip Reservation for at least one year prior to your birth. If you are enrolled in another federally recognized tribe you must apply for enrollment with Tulalip before age 25.

**FUNDING AGENCY:** Tribal hard dollars.

## Family Haven

**MISSION:** Through positive beliefs in families, while offering consistent support, we provide opportunities for youth and family wellness and empowerment.

### SERVICES PROVIDED:

- **Family Preservation Services:** This department provides *Family Preservation* services, *Promoting First Relationships*, and *Triple P*. The service is usually 3–4 months but can end early if agreed upon goals are completed. *Promoting First Relationships* and *Triple P* are proven programs that have specific goals in mind and have a structured agenda for weekly appointments. This is an in-home contract between the Tulalip Tribes and DSHS/DCYF. All referrals come from *bədaʔchəlh* or the state CPS/Child Welfare Programs.

Services provided by these three programs include:

- Crisis management and intervention, including after hours and weekends as needed
- Budgeting, organizing household, meal planning
- Helping families achieve compliance with services
- Accessing community resources including Tribal, State and Federal resources
- Problem solving school issues for students
- Teaching developmentally appropriate parenting techniques and discipline strategies

- Promoting strong bonds between parents and their children
- Advocacy within a variety of systems
- **Teen Advocate Outreach:** A program that provides intensive outreach for hard-to-reach Native males and females aged 13–22 who have become disengaged in tribal health services, school, their community and their families. This staff (1 male and 1 female) consistently work with youth through negative suicidal thoughts, depression and anxiety, getting into and remaining in school, processing and support through addiction issues and how to develop positive relationships with others.
- **Independent and Transitional Living Skills Program:** This program supports youth to effectively transition into adulthood

through a wide range of issues; including legal, getting re-engaged in school, assistance with seeking employment, accessing community resources, setting up bank accounts, helping youth identify needed supports, and offering mentoring. A plan is developed with each youth to work on their specific needs and tasks to accomplish their goals.

- **MOMs Group:** Tulalip Tribes MOMs (Making Opportunities for Moms) Group is a community support group that meets every Tuesday from 11:00 AM to 1:00 PM. This weekly group is for women raising Tulalip or other Native children. It gives moms an opportunity to laugh, learn, and share a meal together. Moms are able to earn baby bucks each week to purchase essential items for baby and family at the MOMs Group store, held quarterly. Each week an educational topic is presented, chosen according to the needs and wants of the participants.
- **Family Voices/WrapAround:** Family Voices is a process where a facilitator works with youth or family to develop an action plan to achieve goals and build on the supports and strengths of the client(s). The process demonstrates respect for, and builds upon the values, preferences, beliefs, culture, and identity of the youth/family, and community.
- **Parenting Classes:** Family Haven parenting classes provide parents with hands-on material to help motivate and encourage positive communication with their children. Each session is culturally sensitive by blending content from *Positive Indian Parenting and Skills for Successful Parenting*—

the 11-session class strives to improve family relationships while providing guidance to raising children.

- **The Triple P – Positive Parenting Program:** It's one of the most effective evidence-based parenting programs in the world. Triple P gives parents simple and practical strategies to help them build strong, healthy relationships, confidently manage their children's behavior and prevent problems developing. Triple P is a flexible program, you choose the strategies you need. You choose the way you want to use them. It's all about making Triple P work for you. This program is designed to help parents raise happy, confident kids, manage misbehavior, set rules and routines, encourage behavior you like, take care of yourself as a parent, and feel confident you're doing the right thing. Referrals for Triple P come from bədaʔchəlh social workers and self-referred case through bədaʔchəlh.

(ALSO KNOWN AS THE 911 GOOD SAMARITAN LAW)

## Translation:

**If you have a friend who  
is overdosing, you can  
–and should– call 911!**



Using fentanyl, heroin, pain meds, benzo's, muscle relaxers, sleeping meds or valium?

Using opioids at the same time with alcohol or sedating drugs can slow breathing and lead to overdose.

### Signs of overdose:

- Vomiting/gurgling/gasping
- Shallow or no breathing
- Unconscious/cannot wake
- Clammy cool skin
- Blueish or purple lips, skin or nails
- Convulsing/seizing

### Please read these O.D. prevention methods:

1. Call 911, state not breathing/possible OD.
2. If person has vomit or foam, turn them on their side to prevent aspirating (choking or drowning in own fluids).
3. Clear airway and attempt to resuscitate/CPR.
4. Administer naloxone if you have it.
5. Stay with person until help arrives.

Naloxone is a lifesaving medication used to counteract opioid overdose.

Naloxone kits are now available FREE for Tulalip tribal members at Family Services 360-716-4400.

Family Services can also help you get detox or treatment.

- **SonoSite Portable Ultrasound:** This in-office, portable, non-invasive, ultrasound system offers striking image quality which aids providers in visualizing detail and thereby improving the ability to differentiate structures, vessels and pathology. Current uses include fetal imaging, abscess evaluations, and ultrasound-guided joint injections

### LABORATORY:

Our nationally accredited lab provides essential in-house testing above and beyond industry standard for a primary care clinic. High-tech machines allow basic and most advanced testing results while you wait.

- **Basic Labs:** Blood counts, liver function, kidney function, electrolytes, urine analysis, urine drug screens, basic cytology and more
- **Advanced Labs:** Immunochemistry to include glandular (like thyroid and prostate), chronic disease testing (such as hepatitis C), and other common advanced testing such as H-pylori for stomach infection, A1C and A/C ratios for diabetes care

## Health Clinic (Karen I. Fryberg): Women, Infants, and Children (WIC)

**MISSION:** WIC, the special supplemental nutrition program for women, infants, and children, was designed to influence lifetime nutrition and health behaviors in a high-risk population.

WIC has been shown to reduce premature births, reduce low and very low birth-weight babies, reduce fetal and infant deaths, reduce the incidence of low-iron anemia, increase access to prenatal care earlier in pregnancy, increase pregnant women's consumption of key nutrients (iron, protein, calcium, vitamins A and C), increase immunization rates, improve diet quality, and increase access to regular healthcare. One of the current aims of WIC is to work on reducing the incidence of childhood obesity.

**SERVICES PROVIDED:** WIC provides nutrition education, breastfeeding support, health screenings and referrals, and monthly checks for healthy foods. Tulalip Health Clinic WIC is able to provide a variety of high-quality breast pumps for clients needing such devices.

**ELIGIBILITY REQUIREMENTS:** Eligibility depends on household size and income. Contact us to determine if you meet requirements.

## Housing

## Legacy of Healing Advocacy Center (continued)

- Weekly healing circles at the jail for women who have been affected by domestic violence and sexual assault. The purpose was to focus on Tulalip women, other native, however everyone was welcome
- Historical trauma
- Provide support to women who attend healing circles

**ELIGIBILITY REQUIREMENTS:** Tribal members, tribal parents, tribal spouses, children of tribal members, other natives, and other survivors of domestic violence/sexual assault, stalking, and human sex trafficking.

### **Who can access services:**

- Services are available to all adult victims/survivors, regardless of gender or race
- Tulalip tribal members
- Parents/spouses of Tulalip tribal members
- Members of other tribes
- Non-native victims/survivors who have a connection to the Tulalip reservation (i.e. the crime occurred on the reservation, the offender is native)

## Marina

**MISSION:** To operate and maintain marina facility in a professional manner, to protect the tribal fishing fleet from harm's way, to ensure areas around the moorage facilities, parking lot and dry storage will not cause adverse impacts or impede water quality standards as well as plan and develop improvements for the future benefiting both the marina and tribal interests.

**SERVICES PROVIDED:** Tulalip Marina currently offers Tulalip Tribal commercial fishermen leased berthage space. We have 65 slips to lease with a long standing waiting list for these slips as they become available. In addition to those leased slips, the marina also provides docking for those Tulalip Tribal members that own and operate as part of our commercial fleet.

Our commercial fleet has access to our loading dock and the use of cranes for their needs during Tribal Commercial and Subsistence Fisheries under the Point Elliott Treaty.

Our dry storage facility is available for our lessees to perform work on their vessels, and for winter storage as needed.

Our staff provides haul out and launch services for our tribal fleet along with monitoring dock safety within our port. Vessel safety at our port is monitored. However, it is the lessee's responsibility to ensure the safety of their vessel within our port.

The Port of Tulalip also has a boat launch available to Tulalip Tribal members for use at no

- Title for the vessel and/or bill of sale for the vessel
- Safety checklist done with the Tulalip tribal fisheries enforcement officers

### **Subsistence permits (when regulations and open seasons are in effect):**

- **Crab:** Valid 3-day permit, limit of 2 crab pots per permit and limit of 12 crab take home daily limit. (Total of 36 crab per 3-day permit)
- **Shrimp:** Valid 3-day permit, limit of 4 shrimp pots per permit and limit of 10 pounds of whole shrimp per day. (Total of 30 pounds per 3-day permit)
- **Clam:** Valid 1-day permit, limit of 75 pounds per 1-day permit, with a limit of 5 permits per year

## Natural Resources: Licensing and Permits (continued)

### Hunting Permits:

#### ■ Subsistence hunting permits.

- **Bear:** 2 tags per enrolled Tulalip tribal member (open around the 3rd week of July each year and close around the 2nd week in December of each year)
- **Cougar:** 1 tag per enrolled Tulalip tribal member (open around the 3rd week of July each year and close around the 3rd week of March of each year)
- **Deer:** 2 tags per enrolled Tulalip tribal member (open the 3rd week of August and close January 31st of each year)
- **Elk:** 1 tag per enrolled Tulalip tribal member (open the 4th week of August and close January 31st of each year)

Each Tulalip tribal member may be designated to hunt with a signed note turned into the Permitting Department, for only 2 other enrolled Tulalip tribal members and are required to leave their personal tags with the permitting staff while they hunt for others.

#### ■ Ceremonial hunting permits:

- An enrolled Tulalip tribal member can come in to the Tulalip Tribes Admin Building and ask for the Natural Resources Permitting Department and fill out a request for ceremonial hunting, this is preferred to be at least three working days before the ceremonial hunt will begin
- This permit requires approval from the Natural Resources Executive Director or to the Fish and Wildlife Director, this is the reasoning for a 3 business day turnaround

## Pallet Shelter

### SERVICES PROVIDED:

**About Us:** The pallet shelter community is the result of a newly developed partnership with local, Everett-based company Pallet. Pallet shelters provide the dignity of private space in a healing community environment. The pallet community is made up of twenty 64-square-foot shelters. Each is designed and constructed with the right balance of efficiency and comfort, including climate-control options. The pallet shelter provides low-barrier access to critical services, a huge stepping stone to long-term recovery.

**Durable:** Pallet shelters are made to last with a 10+ material-year lifespan. They're resistant to mold, rot, and pests and can be easily cleaned as one resident moves out and another moves in.

**Comfortable:** Insulated walls, heat, and air conditioning provide personal climate control and electricity powers the interior lights and outlets for personal device charging. Spacious with 9-foot vaulted ceilings.

**Rapid:** Made of prefabricated panels that are flat-packed for shipping at scale, each cabin can be assembled in under an hour with minimal tools. Shelters can be disassembled for flat storage or reuse.

**Cost-effective:** Pallet offers a cost-effective price point because they use fiberglass reinforced plastic with a foam insulating core for the panels and shelves. Plus, they use aluminum framing.

**MISSION:** To professionally, effectively and fairly administer justice to the Tulalip community as an essential sign of sovereignty.

### TRIBAL COURT/MEDIATION/ELDER'S PANEL DESCRIPTION & ELIGIBILITY:

The Oscar Jones, Sr., Tulalip Tribal Court is established by law under Title 2 – Tribal Justice System, Section 2.05.010 of the Tribal Court Code.

The Tribal Court has personal and subject matter jurisdiction over several matters, including, but not limited to child custody, adoption, child support, dissolutions, domestic violence, guardianships, marriage, name changes, TGA appeals, elder protection, dependency cases, civil complaints, fishing, hunting and gaming issues, forfeitures, exclusions, etc.

The Court may hear contested or mitigated circumstances regarding traffic citations issued by the Tribal Police Department for Tribal members and non-Indians alike.

The Court also hears criminal complaints filed by the Prosecutor's Office against tribal members, and in instances of alleged domestic violence by one non-Indian against a native intimate partner, known as Special Domestic Violence Jurisdiction cases.

Further, the Court may call a mediator to hear and resolve family law matters (i.e., child support and/or custody cases).

The Elder's Panel is another arm of the Tribal Court. The all-volunteer panel of seven Tribal elders hears young, first-time, non-violent offense cases. If the Elder's Panel client successfully complies with the orders of the Elder's Panel, the case is dismissed.

**WELLNESS COURT DESCRIPTION:** Wellness Court is a 12–24 month program that is different from the general Criminal Court system in that it focuses on honesty, sobriety, and rehabilitation in a teamwork setting. Wellness Court works in coordination with Behavioral Health, Healing Lodge, Tulalip Police Department, Prosecution, UW Defense Clinic, Tulalip Health Clinic, and many other departments to provide the support and resources necessary for our participants to begin

living sober lives and reconnecting with their families, community, and culture.

If a participant successfully completes the Wellness Court program their pending case(s) are dismissed. If it is a probation case and they successfully complete the Wellness Court program the probation case(s) will be closed.

### WELLNESS COURT ELIGIBILITY REQUIREMENTS:

- Participant must be willing to change their life
- Participant must be a member of federally recognized tribe
- Participant must be 18 years of age or older
- Participant must have a pending charge for a drug or alcohol related crime in the Tulalip Tribal Court and a combined 365 days of potential incarceration if convicted of all pending charges and revoked on all suspended jail days in active probation cases
- Participant must be diagnosed with drug or alcohol addiction
- Participant must be capable of following program rules and requirements

If the participant meets one or more of the following criteria, defendant will be **ineligible** for participation in Wellness Court:

- Participant is excluded from the Tulalip Reservation
- Participant is a registered sex offender
- Participant is being charged with a violent felony or has exhibited a pattern of engaging in domestic violence

- Participant has another charge pending for which they would be deemed ineligible
- Participant was convicted or has pending charge(s) of sex offense
- Participant has a medical or psychiatric condition causing a degree of impairment or instability such that it would interfere with program participation and functioning

### COMMUNITY SUPERVISION OFFICE

**(CSO) DESCRIPTION & ELIGIBILITY:** The CSO Officer makes reports to the Tribal Court and sentencing recommendations for post-adjudication matters. Clients who are under Court supervision are also monitored for criminal matters. The CSO also coordinates with the Tribes' Central UA department as well as Tulalip Behavioral Health and various other agencies as well as numerous treatment facilities.

### PRE-TRIAL SERVICES DESCRIPTION

**& ELIGIBILITY:** The Pre-Trial Services Officer makes reports to the Tribal Court and supervises defendants released on Pre-Trial Release conditions for pre-adjudication matters. Clients who are under Court supervision are also monitored for new criminal charges. Pre-Trial Services coordinates with the CSO as well as the Tribes' Central UA Department as well as Tulalip Behavioral Health and various other agencies and treatment facilities. Pre-Trial Services is available to anyone who has been released on Pre-Trial Release conditions out of the Oscar Carl Jones, Sr. Tulalip Tribal Court.

## Tulalip Tribal Court: Tulalip Office of Civil Legal Aid

**MISSION:** The Tulalip Office of Civil Legal Aid (TOCLA), under the jurisdiction of the Tulalip Tribal Court, provides free legal assistance to low-income tribal members with general civil legal issues including those that affect safety, family integrity, health, access to public benefits and education. Tulalip tribal members, parents of Tulalip tribal children, and native individuals living within the Tulalip community are served by TOCLA. Special exceptions may be made to allow for the representation of non-native individuals, so long as such exceptions are by TOCLA policy.

TOCLA provides culturally sensitive, holistic and competent legal representation by collaborating with other Tulalip tribal legal and social services. Collectively, they assist clients in identifying legal and non-legal needs and address barriers to accessing services. In the expansion of civil legal aid through TOCLA, tribal members gain greater access to the Tulalip judicial system.

TOCLA operates under applicable Tulalip tribal law, court rules and federal and state law specific to reservation residents. Legal representation by TOCLA occurs under the jurisdiction of the Tulalip Tribal Court. The Victim Legal Advocacy Project may also provide legal representation for eligible civil legal actions in state court.

**SERVICES PROVIDED:** Tulalip Office of Civil Legal Aid (TOCLA): TOCLA has one general civil legal aid attorney to represents low-income community members in general civil legal matters at the Tulalip Tribal Court. The attorney

can help with a large number of civil legal issues, from family law cases, such as guardianships and dissolutions, to public benefits cases, such as Supplemental Security Income (SSI) appeals.

TOCLA requires that a client must be a member of a federally recognized tribe, be low-income and meet financial requirements to be eligible for legal services. Representation may be limited by the following conditions:

TOCLA will provide only Brief Services or Mediation Services in cases where both parties are Tulalip tribal members unless one of the parties is or was a victim of domestic violence, in which case more comprehensive services may be available (See the Levels of Service section below).

TOCLA will provide only Brief Services to individuals who have an issue against a tribal

entity, including, but not limited to, the Tulalip Tribes, the Tulalip Gaming Agency and the Tulalip Housing Department.

**Tribal Parent Advocacy Project (TPAP):**

TPAP consists of one full-time and one half-time attorney to represent low-income community members in dependency cases at the Tulalip Tribal Court. TPAP represents parents and children involved in dependency cases (Youth in Need of Care or beda?chelh) in the Tulalip Tribal Court.

The client must be a member of a federally recognized tribe or a parent of a Tulalip tribal child, and be low-income and meet financial requirements to be eligible for legal services from TPAP. Representation may be limited by the following conditions:

A parent may be disqualified from eligibility for representation if he or she has demonstrated a pattern of domestic violence perpetration, is alleged to have killed or seriously injured a child, has a conviction involving family violence or has perpetrated sexual abuse against a child or is a registered sex offender.

**Victim Legal Advocacy Project (VLAP):**

VLAP consists of one attorney and a paralegal providing holistic legal representation for tribal members or a parent, spouse, or significant other of a tribal member and their children, or a member of another federally recognized tribe. Priority is given to those living within the Tulalip Reservation boundaries, or other individuals (on a case by case basis) who are

victims of domestic violence, dating violence, sexual assault, and stalking. VLAP is a grant-funded collaboration between TOCLA and the Tulalip Tribes' Legacy of Healing (LOH) program.

Eligibility for the Victim Legal Advocacy Project is not subject to Tulalip Tribes poverty guidelines. The measurement used for eligibility is the victim's desire to leave the abusive relationship and maintain her safety as specified in the screening guidelines.

**Tulalip Child Advocacy Project (TCAP):**

TCAP is a grant-funded program that consists of one full-time attorney who provides holistic, developmentally appropriate, and culturally competent advocacy to children and youth who are involved in dependency (Youth in Need of Care or beda?chelh) cases at the Tulalip Tribal Court. Children under twelve years of age are generally represented under an attorney Guardian ad Litem (GAL) model, while children over twelve years of age are generally represented according to their stated interests. Exceptions to this policy can be made by the court on a case by case basis.

Any party in a Youth in Need of Care (YNC) case may petition the court for the appointment of an attorney or GAL for any child involved in a YNC case.

The child advocate attorney will serve as a GAL or attorney of the child or youth until the case is dismissed by the child returning home to the parent(s) or obtaining other permanency, when the youth turns 21 or by dismissal through a court order.



## **Tulalip Tribal Court: Tulalip Office of Civil Legal Aid (continued)**

**Pro Se Navigator:** Another grant-funded position, the pro se navigator, helps Tribal members and others. The navigator can review their filled out court paperwork for completeness, explain how to navigate the Tulalip Tribal Code and generally explain the court process and how to get a hearing date.

### **Levels of Service**

**Brief Services:** Provides guidance only on accessing the judicial system and/or social services plus referrals to tribal and state legal and social services. Because no legal advice or representation is provided at this level, it may be possible to give general guidance only regarding the legal process to both parties.

**Basic Representation:** Legal advice on complex uncontested matters; completing and reviewing court forms and pleadings; advocacy in the form of writing letters on clients' behalf; and guidance on the legal process.

**Full Representation:** Limited representation for 1–2 court hearings to full litigation representation in Tulalip tribal trial court cases, tribal appellate level cases, and administrative level or state and federal hearings is provided. TPAP and VLAP provide full representation to their clients.

**Mediation Services:** Neutral process for bringing about agreement or reconciliation between parties in a dispute.

**ELIGIBILITY REQUIREMENTS:** Clients will be screened for income-eligibility. Income screening takes place EXCEPT for Victim Advocate and Child Advocate Attorneys.

**MISSION:** The mission of the Tulalip Police Department (TPD) is to support—through our words, deeds and actions the visions of the Tulalip Tribes—the tribal constitution, the tribal council, the tribal members, the tribal elders, the tribal youth, and honor the customs and heritage of the tribe and to support the treaties and sovereignty of the tribe.

**SERVICES PROVIDED:** TPD has seven dispatch/communications staff that take more than 120,000 phone calls per year. Officers are dispatched to more 12,000 calls each year and more than 4,000 reports are filed in tribal, federal, and state courts. 18 officers patrol the entire reservation including Quil Ceda Village, while our six detectives complete follow-up investigations of crimes, including drug violations. Eight fish and wildlife staff ensure that Tulalip Tribes' treaty rights are respected and followed by patrolling the usual and accustomed areas, both on water and land.
